This is a Contract between Country Kennels and the Pet Owner whose signature appears below.

Owner expresses to Country Kennels that they are the legal owner of their pet(s), free and clear of all liens and encumbrances, and their pet(s) have received all necessary vaccinations as required. Likewise, pet(s) is/are healthy and have not been exposed to any known communicable diseases within thirty days prior to services and you agree

to inform Country Kennels of any health or behavioral changes prior to subsequent visits. Owner also agrees to allow Country Kennels to withhold pet(s) out of activities until pet(s) is/are symptom-free for a minimum of 30 days or written veterinary release is received. If pet(s) have shown physical signs of aggression toward people or other pets, owner understands that every precaution will be taken to insure the safety of other pets and employees. Country Kennels reserves the right to reject acceptance of any pet that lacks proof of vaccinations, displays any signs of untreated or contagious diseases or demonstrates excessive aggressive behavior. In the event any fleas or ticks are discovered on their pet at check-in, Country Kennels will administer a medicated bath at owner's expense.

2. Owner agrees to pay for all charges in full at time of pick-up of pet(s). If the pet(s) becomes ill or if the state of the animal's health requires professional attention, Country Kennels, in its sole discretion, may engage the services of a veterinarian, administer medicine, or give other requisite attention to the animal and the expenses thereof shall be paid by the Owner. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet(s) while it/they is/are in the care of Country Kennels. This includes payment of costs for injury to staff, other animals, or damage to facilities caused by said pet(s).

3. Owner further agrees that the pet(s) shall not leave Country Kennels until all charges are paid in full.

4. All charges incurred by Owner shall be payable upon pick-up of pet(s). Extended stays longer than 30 days require 50% deposit paid at the time of check-in. Country Kennels shall have and is hereby granted, a lien on the pet(s) for any and all unpaid charges resulting from pets' stay at Country Kennels. The Owner hereby agrees that in the event all charges are not paid in full when due in accordance with this contract, Country Kennels may exercise its lien rights upon ten days written notice given to Owner by certified mail to address shown on contract. Country Kennels may dispose of pet(s) for any and all unpaid charges, at private or public sale, at the sole discretion of Country Kennels, and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of boarding or other delinquent charges, plus costs of sale, then Owner shall be liable to Country Kennels for the difference. All monies realized by Country Kennels at such sale, over and above the charges due and costs of sale, shall be paid by Country Kennels to Owner.

5. This agreement contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Country Kennels.

6. Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.

7. The Owner authorizes Country Kennels to do whatever is necessary for the health and safety of their pet(s) and agrees to assume full financial responsibility for all medical expenses incurred. Owner agrees and accepts all risks and responsibilities for damages that may result from injuries caused by their pet while at Country Kennels. Owner expressly waives and relinquishes any and all claims against employees and representatives of Country Kennels, provided reasonable care and precautions are followed. Country Kennels will not be liable for any consequential damages beyond the replacement value of any pet. It is expressly agreed by the Owner and Country Kennels that liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$400.00 per animal.

8. I, the Owner, of the pet(s) in the care of Country Kennels, Choose Do Not Choose to complete the Health Care Directive (for my elderly/health compromised pet) document provided by Country Kennels and agree to item 2 as listed above.

9. By signing this Contract and leaving said pet(s) with Country Kennels, the Owner certifies to the accuracy of all information given in regard to aforementioned pet(s).
